RE: **POLLING LOCATIONS**

In January, the Delhi Township Election Commission approved new precinct boundary lines. New lines were drawn because the law changed allowing the maximum number of voters per precinct to increase from 2,999 to 4,999. This was done in recognition of so many voters voting a Vote From Home (absentee) ballot. And now with the implementation of nine days of early voting for all state and federal elections, we have begun seeing even less voters at the polls on Election Day. Therefore, the small precinct limit previously in place just becomes more wasteful. We were able to reduce the number of precincts in Delhi Township from 9 down to 7. This will result in considerable savings in our elections. We are also transitioning out of the schools as polling locations. These precinct changes enabled us to remove three precincts from two school buildings. We will continue this transition after the 2026 election cycle.

While the Election Commission approves precinct boundaries, the Township Board approves polling locations. Therefore, I offer the following recommended motion:

RE: **Set Public Hearing – Land and Water Conservation Fund Grant Applications**

The Parks and Recreation Department is in the process of crafting two separate applications for the Michigan Department of Natural Resources Land and Water Conservation Fund Grant Program (LWCF). The Township was awarded two LWCF Grants in 2021 with the Tennis and Pickleball Courts at Kiwanis Park and the Valhalla east restroom (start date March 2026)

LWCF Grants through the DNR require a 50% match from the Township with a maximum grant award of \$400,000 per project, when combined with the match, the Township can develop an \$800,000 project. Planners have developed and estimated scope items to fit within the \$800,000 project totals.

Both projects have been identified in the 2025-2029 Parks Master Plan as approved by the Parks Commission, Board of Trustees and the DNR. The Township's CIP Plan currently suggests \$400,000 in FY 2027 and FY 2028 for these projects, although this has not been budgeted yet and is dependent on the results of the grant application.

The grant applications are as follows:

- Valhalla Park Trail Loop Development
 - Grant request: \$400,000
 - Project Total Estimate: \$800,000
 - Projected Scope: Construction of a ½ mile trail loop around the pond at Valhalla Park including a section of floating boardwalk on the NE section of the new loop; construction of an accessible fishing pier; construction of a new picnic shelter on the east side of the park overlooking the pond; installation of interpretive signage, benches, tables and trash receptacles.

- John Taylor Park Development
 - Grant request: \$400,000
 - Project Total Estimate: \$800,000
 - Projected Scope: Installation of accessible concrete pathways from the parking lot to new features; installation of a new picnic shelter; installation of a playground structure; a scenic

overlook at the wetlands area; a more visible entry sign; a walkway connection from the existing pedestrian entrance to the park on Tunbridge Rd.

As part of the grant application process, we are required to conduct a public hearing to discuss the grant scope and projected budget. Additionally, a Resolution of Support must be approved by the Board of Trustees as well. Historically (as well as allowed under the Grant Guidelines), both the public Hearing and Resolution can take place at the same meeting.

Grant applications are due April 1, 2026 to the DNR with grant award notices in September. The final award is signed by the Governor as part of an appropriations bill, with costs reimbursed (up to the grant award limit) to the Township after project completion.

I am requesting the Board of Trustees set a public hearing for Tuesday March 17, 2026 to hear comments on both grant applications.

Recommended Motion:

To set a public hearing for Tuesday, March 17, 2026 at 5:30 p.m. to hear comments on the proposed Valhalla Park Trail Loop Development and John Taylor Park Development grant applications through the Michigan Department of Natural Resources Land and Water Conservation Fund Grant Program.

WHEREAS, the Township intends at this time to state its intention to be reimbursed from proceeds of the Bonds for any expenditures undertaken by the Township for the Project prior to issuance of the Bonds.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Notice of Intent Authorized. The Township Clerk is hereby authorized and directed to publish a notice of intent to issue the Bonds in the *Lansing State Journal*, a newspaper of general circulation in the Township.
2. Form of Notice of Intent. The notice of intent shall be published as a **display advertisement not less than one-quarter (1/4) page in size** in substantially the form attached to this resolution as Exhibit A.

3. Approval of Notice of Intent and Publication. The Township Board does hereby determine that the foregoing form of Notice of Intent to Issue Bonds and the manner of publication directed is the method best calculated to give notice to the Township's electors and taxpayers residing in the boundaries of the Township of the Township's intent to issue the Bonds, the maximum amount of the Bonds, the purpose of the Bonds, the source of payment for the Bonds and the right of referendum relating thereto, and the newspaper named for publication is hereby determined to reach the largest number of persons to whom the notice is directed.

4. Reimbursement Declaration. The Township may incur expenses for the Project prior to receipt of proceeds of the Bonds and may advance moneys for that purpose from funds available to the Township, to be reimbursed from proceeds of the Bonds when available. The Township makes the following declarations for the purpose of complying with the reimbursement rules of Treas. Reg. § 1.150-2 pursuant to the Internal Revenue Code of 1986, as amended:

- (a) The Township reasonably expects to reimburse itself with proceeds of the Bonds for certain costs of the Project which were paid or will be paid from general funds or sanitary sewer system funds of the Township subsequent to sixty (60) days prior to today.
- (b) The maximum principal amount of debt expected to be issued for the Project, including issuance costs, is \$8,500,000.
- (c) A reimbursement allocation of the capital expenditures described above with the proceeds of the Bonds will occur not later than 18 months after the later of (i) the date on which the expenditure is paid, or (ii) the date the Project is placed in service or abandoned, but in no event more than three (3) years after the original expenditure is paid. A reimbursement allocation is an allocation in writing that evidences the Township's use of the proceeds of the Bonds to reimburse the Township for a capital expenditure made pursuant to this resolution.

5. Bond Counsel. Miller, Canfield, Paddock and Stone, P.L.C. is hereby approved as bond counsel for the Bonds.

6. Rescission. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution are rescinded.

SOURCE OF PAYMENT OF BONDS

With delivery of the new Ossuarium at Maple Ridge Cemetery we need to adopt fees for the niche spaces and ossuary space. It has also been several years since we've updated the cemetery prices, so I'm proposing changes to other fees such as burial spaces, grave opening/closing, etc.

I have included the current pricing and proposed pricing, so you can see the difference. We compared pricing of surrounding communities, and the proposed pricing will put us close to the median for most fees. Another change I made is to have the Clerk's Office determine the Ossuarium niche engraving. We currently contract with a local company, and the Company we purchased the Ossuarium from also provides the service. Because their contracts could change from year to year, I'd like the flexibility to adjust pricing or even who we contract with, without having to bring that small price change to the Board every time.

RE: Amendment No. 1 to Resolution No. 2025-009 – General Appropriations Act for Delhi Charter Township’s Fiscal Year Ended December 31, 2026

Enclosed for your review and approval is Amendment No. 1 to Resolution No. 2025-009 for the FY 2026 Budgets.

Revenues are expected to decrease in the General Fund by \$25,761 primarily as a result in the reduction of revenue sharing expected; while revenues are expected to increase in the Fire Fund by \$31,240, in the Parks Fund by \$21,537, in the DDA Fund by \$271,801 (sale of assets) and in the newly created OPEB (retiree insurance liability) Fund by \$38,733.

Expenditures for the General Fund are expected to increase \$36,327 in Legislative by adding the Treasurer to this fund, decrease \$23,002 in Manager’s Office by moving the retiree insurance liability to the new OPEB fund, decrease \$260,778 in Accounting by removing this fund and combining it with the Treasurer’s Office and renaming it the Finance Department, decrease \$31,089 in the Clerk’s Office by removing the retiree insurances, increase \$189,239 in the Finance Department by adding in the previous Accounting Department, increase \$581 in Assessing, decrease \$17,239 in Buildings & Grounds by removing retiree insurances, increase \$15,967 in Community Development for salary adjustments. Including the decrease in transfers out to Fire (\$138,036), decrease in transfers out to Police (\$31,220), decrease in transfers out to Parks (\$67,883), decrease in transfers out to Fire EMS Equipment (\$99,141), the result is a total decrease of \$301,372 in expenditures which in turn increases the General Fund balance by the same.

Expenditures are expected to decrease \$25,027 in the Fire Fund, decrease \$35,814 in the Parks Fund and decrease \$16,375 in the Sewer Fund by removing the retiree insurance. Expenditures are expected to increase \$48,863 in the DDA Fund with the shift from a part-time administrative assistant to full-

time, increase \$335,403 in the Sewer Fund Capital Improvements and increase \$196,599 in the new OPEB Fund with the transition of the retiree insurance liabilities from each fund.

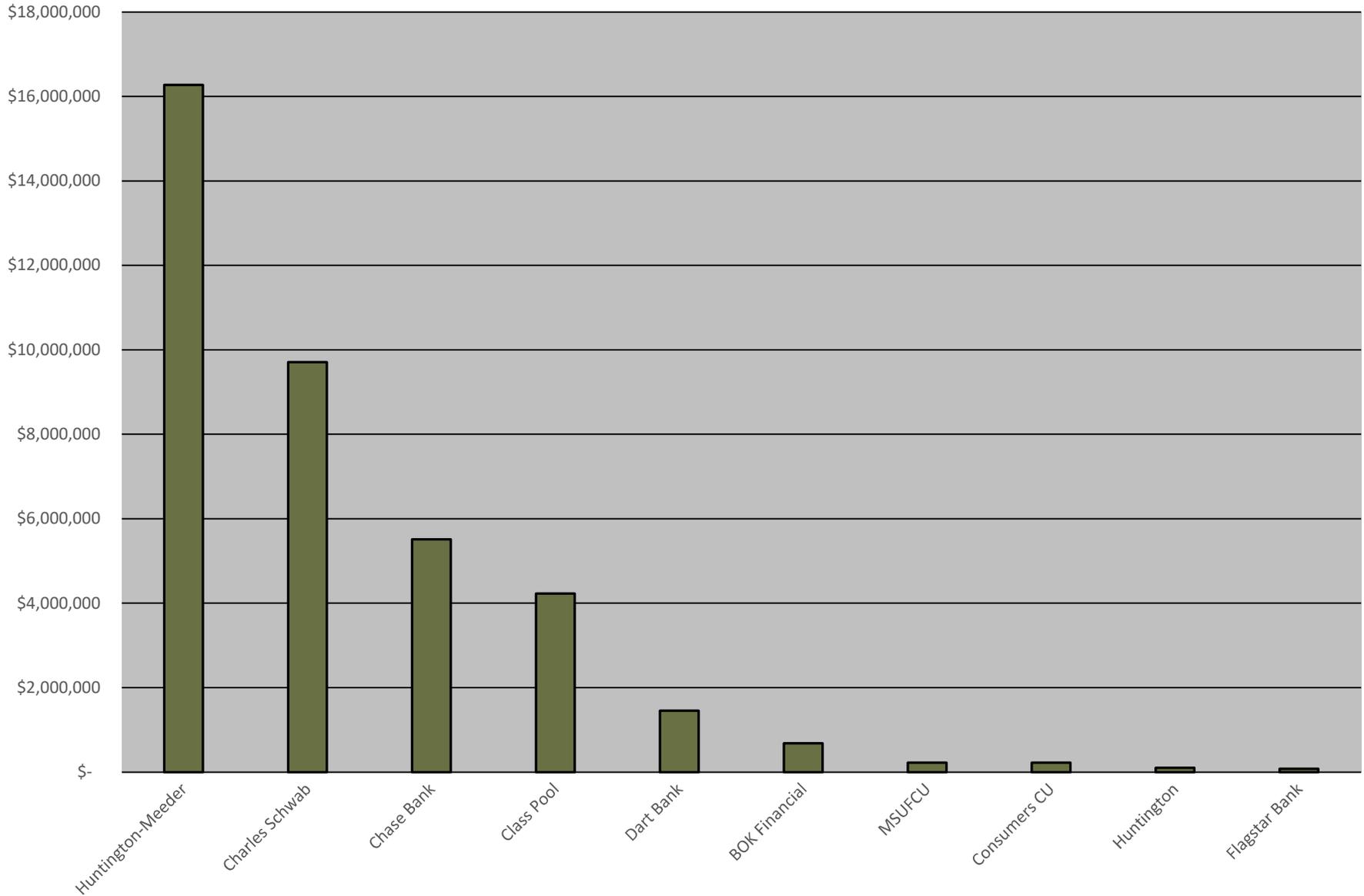

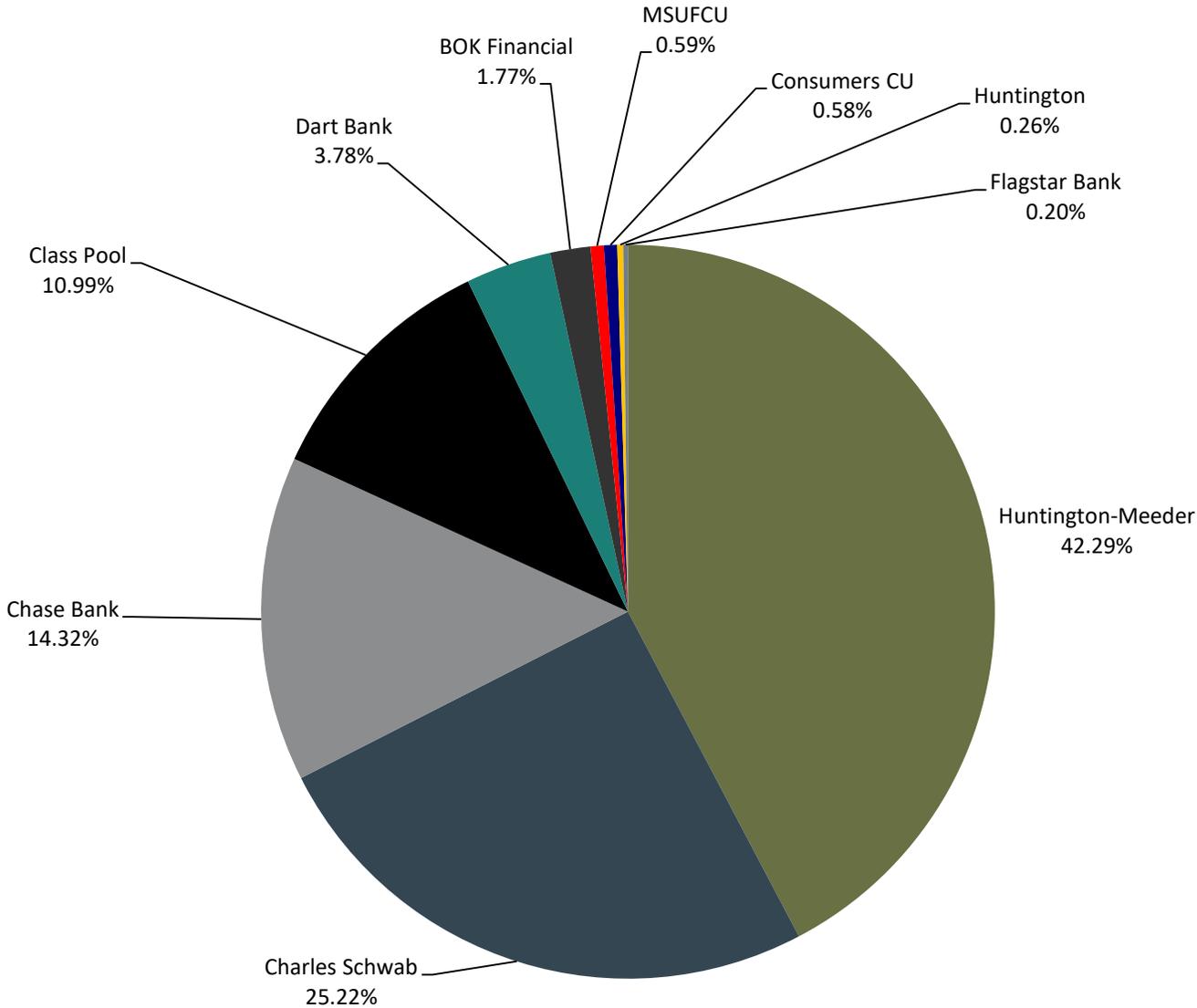
Delhi Charter Township Cash and Investments as of 12/31/25*
