- The location of the proposed or existing sign which is the subject of this application.
- The actual or proposed distance from the sign to each property line.
- The actual or proposed distance from the sign to the road right-of-way line.

*NOTE: In some cases this may be the same as the front property line. However, it is not always the case. The road right-of-way is not the curb or edge of pavement. Please do not provide measurements from the curb or edge of road pavement, sidewalk or other object. You must determine the actual location of the road right-of-way on your site and provide the measurement from it to the sign.*

- The location of buildings, parking and other on-site improvements.
- The easiest way to obtain a base map to use when developing the site plan or plot plan, if you don't already have a property survey or other similar document, is to obtain it from the Township's GIS system which can be accessed at delhitownshipmi.gov. However, please note that you are responsible for verifying the measurements and information presented.

**A drawing of the proposed sign which clearly provides the following information:**

- The dimensions of the sign, including the total display area.
- The height of the sign.
- The distance between the ground and the bottom of the sign (clear area), if applicable.
- If the proposed sign is a wall sign, the dimensions of the wall that the sign will be affixed to. If it is a multi-tenant building, provide the exterior wall dimensions for that suite.
